

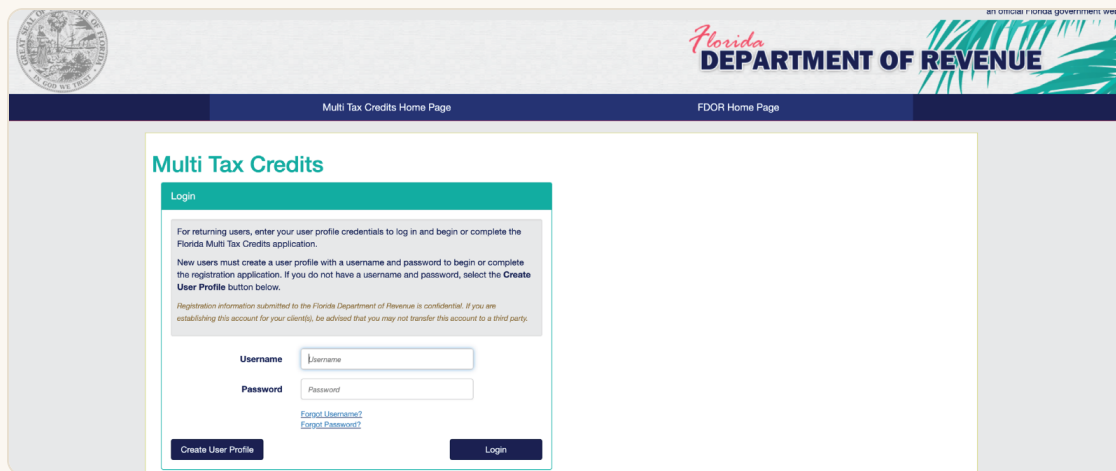
## You can make a charitable donation, and earn dollar-for-dollar tax credit while supporting youth through Helping Advance and Nurture the Development of Youth (Handy).

### YOU WILL NEED THE FOLLOWING TO COMPLETE THE APPLICATION

- Federal ID Number (FEIN), business address, and contact information
- Total amount of the tax liability (and the type of tax) you want to claim credit to offset through a donation to Handy.  
**Please note, you do not have to make the donation at this time.**
- If you file Florida corporate income tax/franchise tax return on a consolidated basis, you will need the name and FEIN of the parent company

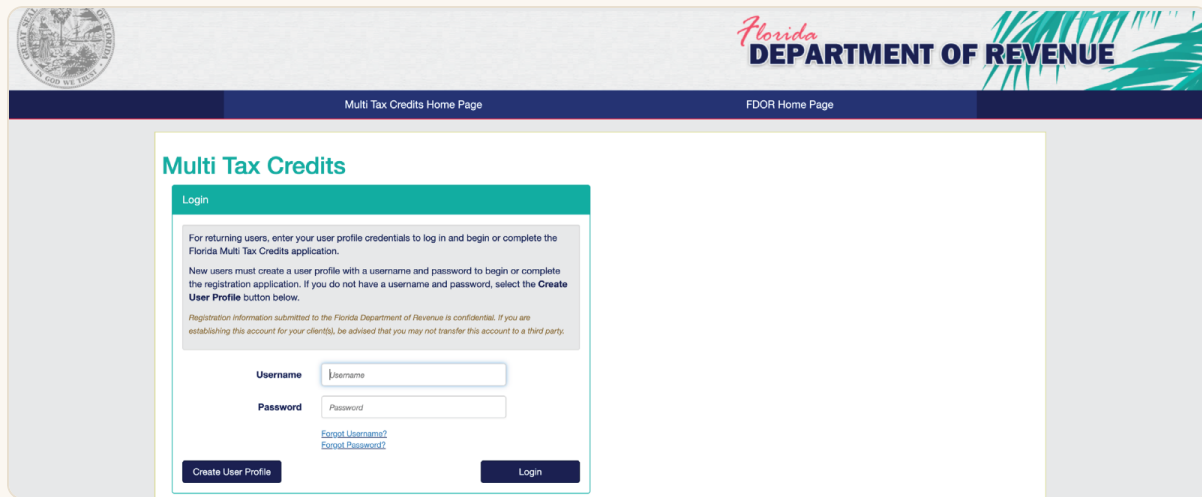
To apply for these funds, please see below for step-by-step instructions. The application should be completed by an officer, owner, or partner of the corporation.

- 1 Go to the [Multi-Tax Credits Application](#) on the Florida DOR website to either verify your login is active (if you already have an account) or to create a user profile (first time users).
- 2 If you already have an account, click “Login”, enter your details, and skip to step 5. Otherwise proceed with step 3.



- 3 If you do not have a user profile on the Multi-Tax Credits Application, go to the [Multi-Tax Credits Application](#) on the Florida DOR website, click “Create User Profile” and create a username, email address, and password.

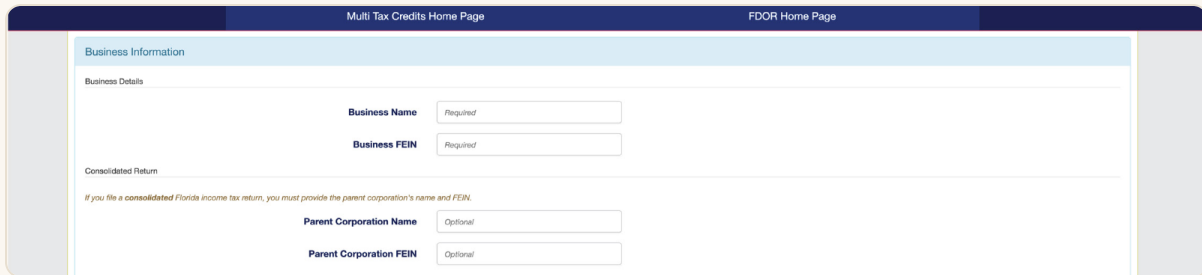
**9** Select the applicable Allocation Type.



**10** Enter the amount of expected tax liability you would like to offset with the Strong Families Tax Credit and your corporation's Tax Year Start and End Date. As a reminder, there is an up to ten year carry forward for unused credits, so there is no need to underestimate your liability.

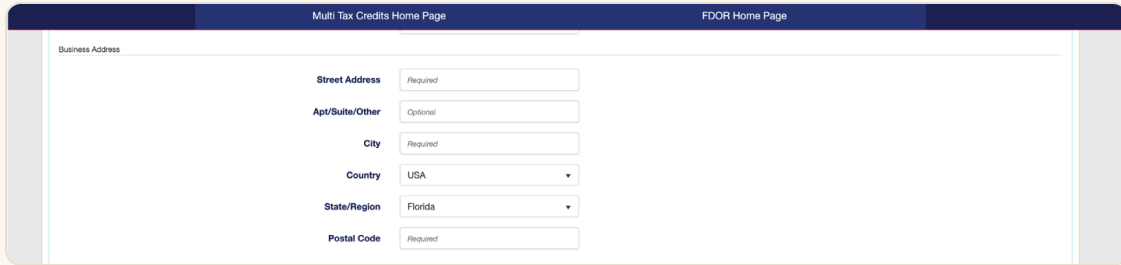

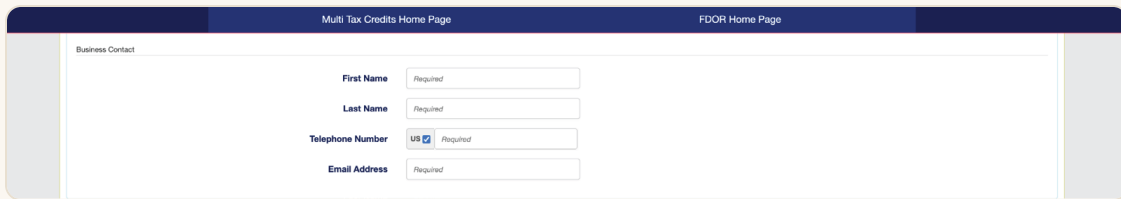

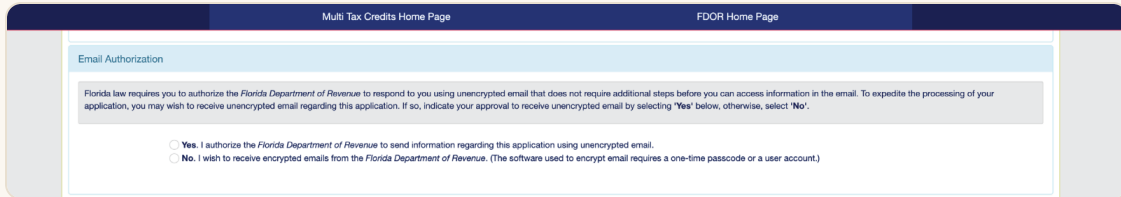

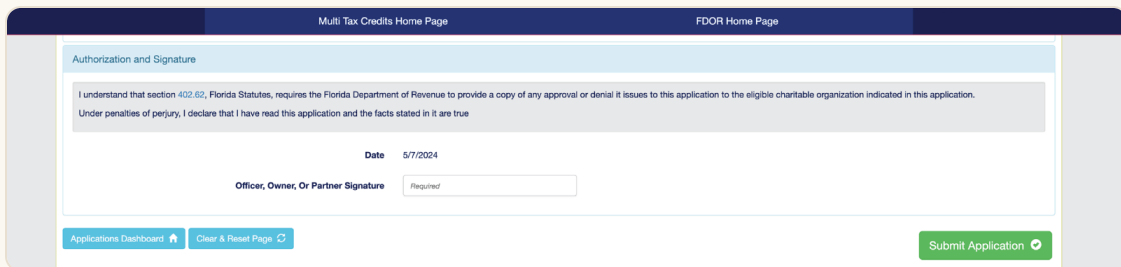

- 17 Once your credit allocation is approved by the Florida DOR, please notify Handy by emailing [kbrown@handyinc.org](mailto:kbrown@handyinc.org) with the following information:
  - Business Name
  - Amount Approved
  - Allocation Type (Corporate Income Tax, Premium Insurance, etc.)
- 18 **Congratulations!** You may proceed with your donation to Handy. Once received, Handy will issue you with a Certificate of Contribution with the date and amount of the contribution. Your tax credit can now be claimed.
